Cowboy Select Sale Nomination Process and Consignor Terms:

All horses consigned must be offered through the sale ring, NO ALLEY TRADING or Private sales are allowed on the premises or prior to the sale, based on our advertising of the horse.

Catalog Nomination / Consignment fee is \$450.

Commission 8% or a minimum of \$800.

Pass out fee is \$800.

Catalog Nomination/Consignment Fee of \$450 must be included with this form for a horse to be nominated for the sale. Nominated horses will be selected by sale staff based on the following criteria:

- Consignor Reputation and Following
- Breed, Age, Appearance and Temperament of the Horse
- Usefulness, Willingness and Performance of the Horse
- Photo and Video Quality
- Sale demographics

Only 40 horses will be accepted. Sale management has the right to refuse any consignment that they believe will not fit the sale. All horses rejected in the nominating process will be returned the \$450 no later than October 31, 2022. Nominations open August 1, 2022 and close when full, or no later than October 15, 2022.

Once a nominated horse is accepted for the sale, the consignor will be notified and has Three (3) weeks to submit the \$800 pass out fee. This pass out fee will be credited towards the commission once the horse sells. In the event the consignor does not pay the \$800 in the necessary time period, the horse will be rejected from the sale and will forfeit the \$450 consignment fee. Cash, Check, Wire transfer and Credit Card payments can be made for the consignment and Pass Out fees. All Credit Card payments will have a 4% transaction fee. All wire transfers will have a \$20 fee. Once a horse is accepted into the sale, there will be **no substitutions and all fees are non-refundable**.

Original registration papers and properly completed/signed transfers of all accepted horses must accompany the horse at the time of check in. Seller is responsible for all transfer fees. Sale staff is not responsible for missing papers or transfers not properly completed. If original papers and completed transfers are not received at check in, or are incomplete, the horse will be announced as grade at the sale.

Nevada is a brand inspection state. All consigned horses must arrive with the appropriate proof of ownership paperwork titled in the seller's name and free from any and all liens.

A current Coggins (within 6 months of sale) is required for all horses.

A Health Certificate (within 15 days of sale) is required on all horses.

All feed, water and care of the horse is the responsibility of the consignor until the horse is sold. Out of respect to the purchaser and the horse, we are requesting consignors leave 1 feeding and a bucket of water in the stall after the sale. *(Check in times subject to change)*

Horse check in – to be announced. Stalls from check-in to sale day are included in the consignment fee. Any stalling needs prior to check in will be the responsibility of the consignor. The first three bags of shaving are included in the consignment fee. Any additional bags may be purchased from the sale staff.

There will be a veterinarian available by appointment on Thursday December 8 and Friday December 9. At the buyers request, any consigned horse can be submitted to a vet check at the buyers expense.

Check out – All horses must have a PAID RECIEPT from Sale Office before leaving the sale building. All horses must be out the sale building by 10 AM Saturday, December 10, 2022. NO EXCEPTIONS. Stalls are scheduled to be removed Saturday afternoon.

If buyer is unable to pay for a horse sold in the sale, Gold Spur Productions, LLC has the right to resell the horse or return it to the consignor.

Marketing pictures and a quality video help sell your horse. Once your horse is selected for the sale, please send up to 10 high quality photos that will be displayed on our website and social media outlets. Gold Spur Productions, LLC will have final say on which photos are used in the catalog based on format and available space. One video link will be shown on our website. Video will also be shown during the sale. Please keep in mind that the first 2 minutes of your video are the most important and gain the attention of potential purchasers. Upon submitting the photos and video, you grant permission to Gold Spur Productions, LLC to use the media as they see fit to help attract bidders to the sale and future sales. Media will be used in a variety of platforms, including but not limited to internet/website, various social media platforms, print and online catalog, television commercials and/or other marketing and advertising, both in print and online.

The consigner is responsible for calling attention to any errors or omissions discovered in any advertising or marketing so the sale company can make the corrected announcements on sale day.

Consignors will be notified for preview times and dates as the schedules are finalized. Arena time will be scheduled for exercising horses. Consigner/Rider of the horse will need to sign a waiver of liability release to use the Resort World arena facilities.

Gold Spur Productions, LLC acts as an agent between seller and buyer. All guarantees are between seller and buyer. Seller further agrees to the following specific soundness guarantee for this sale:

All horses ridden through the ring are guaranteed sound prior to the sale and for 24 hours following the sale, unless stated on this consignment form or stated from the auction block on auction day. Horses are guaranteed to be sound on all 4 limbs, have sight in both eyes and be good in wind. Gold Spur Productions, LLC (Bob and Brandy Edmonds) will have final say over any issues in the soundness guarantee. If a horse is returned and deemed to conflict the sale's soundness guarantee, the consigner agrees to pay the consignment fee and the 8% commission or minimum of \$800, in addition to taking back possession of the horse.

Gold Spur Productions, LLC will mail consigner checks within Seven (7) business days from the date of sale. Deductions from the sale price will include the remainder of the 8% commission if applicable, NV brand inspection fees (\$25) and sale veterinarian fee (\$25).
